**John made a motion to pay the Scrub Oak Scramblers invoice for \$400.00, seconded by Dave S. All were in favor.**

### **Nature Conservancy**

John Lougee from The Nature Conservancy came before the committee to discuss applying for a grant to help the cost of doing a controlled burn in the pine barrens. John explained there is an opportunity right now through a forest service program called a fire strategy grant where John could include some work on the Town Forest. He explained the grant would be submitted in collaboration with the state. He went on to explain there are two pieces of planning that need to happen to apply, one being a fire management plan that includes mapping to show what areas are being burned and it would lay out objectives of how the burn would be done safely, the second thing needed is writing a burn unit management plan that outlines if you have several acres how it will be burned safely. He went on to outline the cost involved in writing each plan. To write the fire management plan would be around \$3,000.00 and that would be the Conservancy's cost, the burn unit plan that is a more specific planning document would be around \$500.00. There may be some prep involved which would require a high-pressure mower at the cost of \$500 –\$600 an acre. The burn itself could cost around \$6,000-7,000.00 a burn.

Ernie pointed out that Cubby is a fire warden and Rob Cunio is the fire chief. The timeframe is very short to apply. The application is due December 21<sup>st</sup> making the timing very tight this year. Ernie explained the FAC is a sub- committee to the FCC. Discussion ensued.

It was decided the timing is to tight this year and the FAC will recommend to the FCC to move forward for next year. David Straw will take the information back to FCC. The goal this year is to get the Fire Management Plan done at the Conservancy's cost. Jeff will send details to Chairman Paul Elie.

### **Pedestrian Bridge**

Dave C. confirmed there is a \$25.00 notification permit is needed the bridge needs to extend beyond the banks. Structural integrity of the bridge still needs to be addressed. Best management practices need to be followed to ensure the bridge is safe.
