

Public Officials Meeting
Wednesday, October 26, 2022

Chairman Les Babb called the meeting to order at 6:00 PM. Present were Selectmen Les Babb, Ernie Day, and Melissa Florio, and Ellen White, Town Administrator, who recorded these minutes. This meeting was held at the Town Hall.

Also in attendance was Jayne Britton, Treasurer; Libby Priebe, Town Clerk; Lindsey Pettengill; Janet Meyers; FAC Representative; Pat McCoy, Trustee of Trust Funds; Bill Elliott; Anne Cunningham, Planning Board & Town Office Advisory Committee Representative; Jeff Nicoll, FCC Representative; Rob Cunio, Fire Chief; Jamie Mullen, Police Chief; Ned Kucera, FAISC Representative; Peter Keenan, ZBA Representative; Rick Davidson, Committee on the Aging Representative; Robin Waters, Library Trustee; and Paul Mathieu, Library Trustee.

Les thanked all for coming to tonight's Annual Public Officials meeting. Ellen distributed budget review schedules, budget worksheets, and year-to-date budget reports to all department, board, and committee representatives in attendance.

Treasurer – Jayne Britton stated it is her first time attending this meeting and questioned procedural items including when unprocessed checks should be voided, verification of employee hours reported on timesheets and who is responsible for corrections after payroll has been processed, and compensatory time off. She further questioned the status of a replacement for the bookkeeper and Tax Collector positions. Ellen responded that cross-training of existing employees will take place to fill the seasonal bookkeeper vacancy. Les responded that the job description is in the process of being drafted for the Tax Collector and will be advertised very soon. Jayne stated that copies of returned checks need to be distributed to the bookkeeper.

Planning Board – Anne Cunningham reported the board has been busy with proposed changes to the Zoning Ordinance to be voted on in March. Many of these changes are being proposed by Gary Williams due to a thorough, well done job he is doing, and to make more sense. STR regulations will be updated as will workforce housing language due to new legislation that passed. If this is not changed in March, the current senior housing standards of 1/4-acre lots will apply to workforce housing as well. The workforce housing standards are between 1 acre and 2-1/2 acres.

Town Office Advisory Committee – Anne reported that Sean and Kate from Bergeron Technical Services have presented plans for 3 options to renovate the existing Town Office. The Committee has narrowed down to 2 options for consideration and will continue to review these options for consideration on the March ballot.

Health Officer – No one present.

Police Department – Jamie reported the department has applied for and received grants to acquire three new AED's, a radio and a spotlight for the new cruiser. Officer Diaz has been responsible for these acquisitions. He attempted a grant for a new drone and radar sign but was unsuccessful. The current roster is stable with more recent interest in part-time positions. Officer Diaz will be attending full-time academy in January and coverage from surrounding towns will be brought in to assist. Officer Diaz has been busy with traffic stops while Sgt. Laferriere has been dealing with prosecutions. Directed speed patrols continue in areas of concern. The Drug Take Back Day is this Saturday from

10-2. Freedom has partnered with Effingham to host this event. There has been an increase in details and calls for service as well as limited staff across all agencies. Jamie is working on training and policy changes including use of force and driving. Libby questioned the process for reporting repeated offenders failing to yield. This is a noted concern at the intersection of Loon Lake Road and Nason Road.

Fire-Rescue Department – Rob reported call volume year-to-date is at 356. The department has also done well with grants used to acquire new cardiac monitors and AEDs at a 10% match, and an 11-year-old boat, motor and trailer package valued at \$74,000 through government surplus at no charge to the town. The Firefighter's Assistance Grant will be applied for again to replace Engine 2. The new Rescue is on track for arrival in February 2023. Everyone has been very helpful and cooperative. The FAC/FCC committee worked diligently to complete a trail renaming project to clear up confusion between the winter/summer trail name variations. Rob is also working on a grant to complete fire pond dredging. There is new staff at DRED and money will be opening up for availability. Les commented that the department has done a great job with obtaining grant funding.

Conservation Commission – Jeff stated the Commission continues to review ZBA applications for best management practice of stormwater runoff and erosion control as well as applications relative to shorefront impact and tree cutting. A workshop with Green Mountain Conservation Group will be scheduled to review the water quality results. The preliminary data is the final data due to the labs being backlogged and unable to test the samples. This data will be reviewed to determine how it can be used in action items. A presentation before the Board of Selectmen will be scheduled prior to February. The trail maps have been developed and are awaiting final costing along with the trail medallions and information for the trail kiosks. The easement monitor was satisfied with the work completed and good feedback was received from recommendations made by Barry Keith. The Commission was successful in establishing a revised Forester agreement. The FAC has voted in a new chairperson and they are strategizing to reopen communication. A joint meeting is scheduled between the FAC and FCC next Wednesday, 11/3 to review the scope of work, budgets, etc. Les questioned if the water quality test results will be included on a graph in comparison to prior years? Jeff responded that the data will go back as far as it has been compiled, 5-10 years normally.

FAISC – Ned stated he provided an update to the Selectmen a few weeks ago. 2022 was budgeted for 2-weeks of diving and 20-acres of herbicide treatment. No herbicide treatment was needed and diving was completed in the usual spots. The 2022 grant was for a 50% match. Ned estimates the same amount to be budgeted for 2023. Ned reminded to submit for grant reimbursement for all invoices processed. Ellen confirmed this has already been done and reimbursements have been received. Les requested a note be made to look at the money remaining in the 2022 Warrant Article for consideration of encumbrance.

Forest Advisory Committee – Janet mirrored Jeff's comments, the Committee will be working through the budget at the Joint Meeting scheduled.

Heritage Commission – No one present.

Committee on Aging – Rick, on behalf of the Committee, is in support of the efforts of Renee Wheaton and the continuation of her position as Senior Resource Coordinator. Renee puts in much more than is expected. A report was submitted in place of her attendance (attached to these minutes). Renee and Rick collectively are on 4 different committees and are involved in the Gibson Center. A

lot of accomplishments have been made and senior trips will start up in November and December. There remains concern with transportation and Renee is working to obtain her license to drive a bus. Other initiatives in the past have failed and they do not want that to happen again. Energy initiatives are also in progress.

Library – Paul and Robin are present. They have seen an increase in patronage since Covid. Programs are resuming, Freedom Elementary students have returned as well as some youth programs. Adult programs are still behind and they are hoping for redevelopment there. The book sale was brought back and the Elizabeth Morrow donation has been settled and will be used as intended for the benefit of the library. The entrance upgrades have been postponed until spring due to anticipated frost.

Supervisors of Checklist – No one present.

Town Clerk – Libby stated her goal is to sit down with Ellen to figure out a way to obtain a Deputy. Lindsey Pettengill is a potential candidate if it can work. 8,224 transactions have been completed year-to-date with \$349,000 collected. The Deputy position will require training and transition with 3-4 days of in-person training to take place in Concord. A full-time position may be difficult to obtain without sharing responsibilities elsewhere. She and Ellen will discuss further.

Trustees of Trust Funds – Pat reported interest rates have increased from less than 1% to almost 3% yielding a better return on investments. Current trust fund balance is \$1,836,128 with approximately \$300,000 in request to be withdrawn.

Town Administrator – Ellen thanked all employees, boards, and committees, and the Selectmen. Starting in late 2019, and shortly after entering into a pandemic that led into the Town Office closure from March until the following May, staffing turnover, 2022 is the first year that seems to be back to normal and a true determination of how Freedom operates. Everyone has been very supportive. The goal has been to keep the communication open and will continue to be. Changes have been made at the Town Office and Transfer Station, and continuing to move forward. Tax dedeed properties are being sold back to former owners or sold to be put back on the tax rolls to bring the tax revenue back into the town, staffing turnover has been experienced in all departments, we're running a tight budget with very frugal department heads not spending foolishly and making application for grant funding wherever its available. At the Town Office, efforts are being made to digitize town records and to help with document storage with the lack of space which will be addressed hopefully by the Town Office Advisory Committee. Sam Porter has been brought on staff as office support and has been helping to digitize the building files into the building permit software, and then onto other records, and a rather large shredding project for files and documents that are no longer necessary. Focus on preserving historical documents will be in site to preserve the history. Melissa commented that the right equipment needs to be obtained to accomplish these tasks. Ellen responded that there was a Warrant Article this year for new equipment to be purchased including a map scanner and shredder and those will be ordered by the end of the year.

Board of Selectmen – Les reported they have been making changes to the Transfer Station with more to be presented. A full-time member of the Highway Department left in early October and they were fortunate to find a young man with a CDL license to fill the position, as well as another person to fill the part-time seasonal position. The Danforth Bay Bridge has finally been completed and all reimbursements have been received from the State Bridge Aid Program. A Regional Ambulance Meeting was held Monday and the option of a contract extension was proposed at the same 3% annual

increase. This regional agreement has proved effective and the Board is happy with the level of service provided. STR's are still a work in progress. A group are in non-compliance and the Board is working with legal for action to be taken. Les anticipates a Supreme Court suit will be the deciding factor on the disagreement of commercial use versus residential use of a property.

Reports were submitted by the Emergency Management Director, Safety Officer, Senior Resource Coordinator, Tax Collector, and Zoning Officer/Building Inspector who were unable to attend (attached to these minutes). The Moderator and Town Building Custodian were also not able to attend due to other commitments.

Adjournment:

Being no further input, Les made a motion to adjourn. Ernie seconded. All in favor, the motion passed.

The meeting adjourned at 6:53 PM.

This report will summarize the activities of the Freedom Safety Officer for the period January 1 to October 26, 2022.

The participation of Department Heads and Town Employees in the quarterly Joint Loss Management Safety Committee (JLMSC) quarterly meetings generally remains strong. The cooperation of Department Heads and employees continues to be excellent. Quarterly meetings continue to take place at the Highway Department facility with lunch being provided to the participants.

Safety Issues Discussed

Safety related training available through Primex was distributed to department heads and employees at the March Meeting. The need for town officials IDs was a continuing discussion and Town Administrator White advised that she researched the town official ID issue and advised that she will design the ID and have them made by the Town of Ossipee or a commercial entity. We discussed the Masonic Hall roof snow shed issue and parking warning signs will be made in time for the winter season. It was also mentioned that a rail for the ramp at the Masonic Hall is needed. TA White mentioned snow coming off the roof oftentimes damages the railing. A discussion ensued concerning the various health and safety issues at the town offices. It was the consensus of the group that we will have to wait for the results of the Town Office Committee report to be issued. TA White advised the group that Horizons Engineering will issue their final report on their analysis. SO McClare advised that he took part in the recent elementary school security and safety assessment with Kevin Partington, NH Homeland Security Emergency Management trainer. It was reported that the school assessment went well with the following areas noted as suggested improvements.

1. Main Entrance
 - Office Area Glass Is Not Ballistic Glass
 - Outer Door Controlled Electronically
 - Bollards to Prevent Vehicle Breach
 - Other Doors – Vigilance to Ensure They Are Always Secure
2. Window Glass – All Windows Should Have Wire Reinforcement

3. Kindergarten / First Grade Play Area Fence Is Not High Enough

 - Goal is to look at transportation options across Carroll Country
- MWV AARP Age Friendly Community Steering Committee
 - This group works to provide a framework for assessing and improving the region's ability to become more Age-Friendly
- Lifelong Maine Community Leaders
 - This group is part of UMaine Center on Aging and works to provide information regarding initiatives for senior living and program details from different organizations. This group has provided details on how small rural communities can thrive with an aging population
- Gibson Center Programs and Services Committee
 - Goal is to coordinate programs between Gibson Center and Freedom to provide more programs and different types of social activities
- Carroll County Public Health Advisory Council
 - Work with the different health agencies to provide services to our residents and updates on health needs in the MWV

A grant was received from CDC to provide transportation for the residents of Freedom and Eaton. This grant will cover the cost of the wages for the driver and the van mileage and maintenance.

Since the grant was received the following activities have been completed:

- August - Portland Seadogs game with 9 attendees
- October - fall foliage tour with Cannon Mtn tram 5 attendees
- November - Brownfield Store or Cornerstone Country Market in Waterboro, ME - either trip will include lunch out
- December - Portland Christmas Activity Day out (TBD)
- As soon as a driver has been hired there will be weekly trips to Conway. This will occur on Tuesdays. There will be one pick up in Eaton and up to two pickups in Freedom. There is a need to determine the location of the pickups. The area has to allow for resident vehicles to be parked for the day while gone.

I have completed the necessary coursework to be considered a driver for the van. I will continue to work out the other requirements necessary to be a driver.

It is important that we encourage the use of this service. If residents do not use the service, we cannot continue to offer it and possibly work to add additional options.

Flu vaccine clinic is scheduled for October 29 in coordination with Freedom Village Store - individuals need to sign up so the nurse can be prepared

Currently individuals are concerned about the following:

- Respite care

- Energy assistance (electric & fuel)
- Home maintenance/modifications for safety
- Food security

Being an employee of the Gibson Center in a similar role has also helped with the coordination of services in Freedom and allowed me to make more connections related to both positions.




